RESOLUTION TO CANVASS VOTE

RESOLUTION NO. 2024-R006

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF SPRINGERVILLE, APACHE COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 30, 2024.

WHEREAS, the Town of Springerville, Apache County, Arizona did hold a primary election on the 30th day of July 2024 for the election of two (four-year term) council seats for the Town of Springerville; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Springerville, Apache County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the poll lists, was 362.

SECTION 2. That the number of ballots rejected was 0.

SECTION 5. That all Council seats were filled at the Primary Election.

SECTION 6. This resolution shall be in full force and effective immediately upon its adoption.
