Mayor Nedrow also said another thought to consider was moving the public works department move into this building.

Chief Nuttall said that the front offices could possibly work for police offices and the room with the built-in shelving could be used as the evidence room.

The departments were each asked to write down their pros and cons regarding the build and the council would meet in another work session to discuss them and ideas.

He said the problem is that he ran the numbers compared to their bottom line budgets from last year and what they predict to be at the end of this fiscal year, they've asked for a total of a million dollars in increases. (Wish lists) We don't have that money for everything they want. He said he would like to look at not doing any capital equipment expenditures this year but acknowledged it's up to the council. We're drawing down out of our reserves. The police department due to their retirement and ERE's are actually \$80,000 away from a million dollar budget. He will bring a budget this year that will look at the needs versus the wants and try to go one more year without some of these items. We are adding revenue from savings account throughout the year.
